

Part I: Introduction & Personal Experience

Introduction

Hello,

My name is Mark Rich. In this video I'll give an overview of a series that will explain a unique form of oppression appearing worldwide.

Although it has many names, basically it consists of persecution by a large number of citizens, advanced surveillance and communications technology, and directed-energy weapons.

Personal Experience

Before I tell you what this series will include, let me briefly describe my situation.

In late 2004 I realized that I was under attack. However, some of the sensations that I have since attributed to directed-energy, occurred when I was 17.

Furthermore, some dismal events, which I now recognize as *planned tactics*, started in my late teens. This may go back even earlier.

The hostilities increased when I started to sense what was happening, and have intensified at different periods since then.

Status

What follows is a summary of my status:

- I receive a never-ending rotation of varying degrees and types of pain, induced by **directed-energy weapons** (DEW). These strikes leave no visible injury.
- I'm often hit with **negative emotions** such as disgust and anger.
- My mind is blitzed with **repulsive images**.
- I'm exposed to a nearly constant **auditory stream** of the same phrases, repeated in a cyclic mode.
- All of my personal **electronic devices** malfunction.
- The *Computer Network Operations* (CNO) include endless **computer problems**, from the hardware to the internet level.

- *Psychological Operations* (PsyOp). Insulting and **threatening messages** are conveyed through a variety of channels.
- **TV and radio signals**, data files, and **web pages**, are regularly spoofed with PsyOp messages. The spoofing extends to printed material.
- I'm *swarmed* out in public by citizens who "accidentally" **collide** with me. Some have blatantly **shoved**, **kicked**, and **punched** me.
- Group Setups and Staged Accidents. Citizens are colluding to portray me as offensive. They have also conducted **staged accidents** involving moving vehicles.
- Area and Resource Denial. I have been **expelled from multiple places**, often because citizens alerted security and police after staging a confrontation.
- My personal belongings are routinely **sabotaged**.
- **Financial disruption** and **unemployment**.
- Since October of 2011 I've been **steadily homeless**.
- I have a permanent **medical injury** for which I've been denied genuine medical treatment.
- I've been **electronically isolated** from my peers, friends, relatives, and society.

Documentation

After discovering that I was under attack, I started to research and write about this and other topics.

I learned there are explanations for most of this, which can be found in papers released by governments, think tanks, defense contractors, and the military.

Those documents contain the terminology that I use in my **articles** to explain this new *war-form*.

Some of you may be familiar with two of my books, ***The Hidden Evil*** and ***New World War***, published in 2008 and 2011, respectively.

Part II: Topics & Methodology

Topics

This is an issue that spans numerous domains. When exploring it I made some unexpected discoveries that amazed me.

Here is an overview of some of the topics that will be examined in this series:

- A description of the issue. We'll see how what is happening signifies a new *war-form* that has been created to attack specific individuals and groups worldwide.
- Controlling Faction. We'll have a look at the *ponerogenic* organizations that are directing this.
- Profile of a typical *targeted individual* (TI). Here we'll observe the traits of the individuals they are attacking.
- Weapons and Tactics. The virtually traceless methods that the *financial elite* are using to neutralize people.
- *Human-Computer Intelligence Network* (HCIN). A supercomputer with *artificial intelligence* (AI), equipped with sensors and *directed-energy weapons* (DEW). This global *C4ISR* system (Command, Control, Communications, Computers, Intelligence, Surveillance and Reconnaissance), is the critical support structure for modern tyranny. It remotely: trains citizens, attacks *targeted individuals* (TI), and directs *battleswarms*.
- Technology. We'll explore the *mind-reading* machines that are part of the *HCIN*.
- Psychopathy and Ponerology. In these videos we'll learn about the psychopaths and their *ponerogenic* front-groups.
- Purpose. This covert program has several uses, including: installation and maintenance of a global government; negative eugenics; social control; and entertainment for influential psychopaths.
- Civilian Warfighters. We'll see how the financial elite are using citizens to destroy what's left of the free world.
- Complicity Percentage. In these videos I'll provide evidence that the *mass base* of the civilian population has already been recruited.
- Obedience. Why the average citizen didn't resist when they encountered this part of the system; what most ordinary people can be made to do; and what citizens all over the world are doing.

- Average Citizen. Here we'll look at some details regarding the peak development of a typical person. We'll learn: where most people are on the scale of human evolution; how they are integrated into this defiled society; and what they *really* value.
- Cover-up. The organizations that have been covering this up for decades. They are: medical system (mental health); elected officials; legal system; nongovernmental organizations (NGOs); arising TI movement; mass media; independent media; and the citizens themselves.
- What Can Be Done. Methods to expose it based on what I believe to be a proper view of the matter.

Methodology

In this series I'll be traveling through certain *areas of operation* (AO) while recording the attacks. You'll see just how a *host nation's* resources are used in a form of warfare that was designed to be concealed in democratic countries.

Before that, it will be necessary to exhibit some documentaries which describe the weapons and tactics.

Then, you will be able to recognize a covert battle taking place in the civilian sector, which a casual observer would have disregarded.

Part III: Civil Degeneration & The New Tyranny

Civil Degeneration

There have been periods when entire countries underwent a process of civil degeneration.

Some have described it as a *disease* that starts at the top and eventually spreads to every single town.

When it happens, there are individuals who manage to inoculate themselves.

From their vantage point, they observe their fellow citizens involved in malicious activities.

Their solitary testimonies alerted us to abominations that would have otherwise escaped the historical record.

The New Tyranny

Each successive tyranny was similar to the previous, yet not exactly the same. At first, the new versions were difficult to recognize, because of some mysterious attribute.

Now we arrive at the premise of my message for you today: This civilization has fallen to a social contamination, unlike any we've seen.

You will not hear about this on the evening news. The establishments that we rely on to expose such things have predominantly failed us in this realm.

When the major institutions which direct societal development are ineffective, the citizens themselves must resolve the issue.

Unfortunately, that will be difficult.

Complicity Percentage

The modern tyranny features highly advanced technology that reaches, literally, into the mind of the individual citizen.

I've determined that an enormous number of people are already connected to this system.

In reality, these *electronically constrained* citizens do not have the freedom to organize any practical remedy.

Furthermore, the extent of complicity makes it obvious to me that many do not have the will or ability to efficiently deal with this.

Because of a collective refusal to accept responsibility for this matter, it is now an epidemic.

In my opinion, this must be one of the most crucial issues of our time, impacting many societal quarters.

Part IV: Exposure & Evidence

Exposure

The wealthy rulers of this society have used this hidden system of terror with impunity for decades.

Many people are still unaware of the origin of their physical and psychological afflictions.

Some are being murdered with directed-energy that mimics the symptoms of fatal illness. Others are ensnared in the mental health or prison systems.

Those who recognize what is happening have an advantage. However, that was not always so.

Previously, reports on the weapons and tactics were rare. So those under attack had no solid basis to rationally explain their case.

Additionally, even though evidence resided in the behavioral sciences regarding obedience and psychopathy, it wasn't well-known.

Fortunately, things are quickly changing.

A Profusion of Evidence

There are now many official reports on the weapons and tactics. Some of them explicitly tell us they will be used on citizens.

Then there is the social psychology data released in recent decades. In particular, the experiments and journals on obedience.

These studies, and variations of them, have been repeated in multiple countries since the 1960s. The results are broadly consistent. Submission to a repugnant authority is the norm.

By virtue of this information, it seems doubtful that most average people would have resisted this *hi-tech slavery*, especially when their decision to submit was made in secrecy, and they were virtually guaranteed not to be exposed.

Financial Elite

For at least a century, many notable figures have warned us about a *financial elite* carrying out a plan of global enslavement.

Opinions vary regarding the entities that are ultimately responsible. In my estimation, this appears to be part of a hostile extraterrestrial scheme. Although that may be so, reputable scholars have shown that the upper echelon of this control structure includes organizations that in fact exist.

It has also been established that the directing factions of these seemingly benevolent groups are composed of psychopaths.

The formalized profile of these characters gives us a clue as to how they've been using *host nation* (HN) resources to attack citizens.

What Can Be Done

There are different beliefs pertaining to the nature of the problem and how to fix it. In this briefing I won't make any detailed statements on what I think can be done.

I will say that the efficiency with which you handle a dilemma is mostly determined by the accuracy of your perspective.

Part V: Closing Statement

Some of us are familiar with historical examples of injustice, that, for one reason or another, transcended most of the minds that encountered it.

Eventually, it reached principled individuals of certain inclinations who interpreted it differently. They formed a mighty opposition with like-minded people.

Then, a civil bane that most others considered insurmountable, was brought to light.

Perhaps, during a future revival, it will be common knowledge that an obscure monstrosity once thrived, until a special group of people accepted the bleak task of thoroughly exposing it.
